In April 2015, the Company entered into a Cash Advance Financing Facility with Capri Trading Pty Ltd. During the previous quarter, the Company entered into an agreement to extend the repayment date and now agreed to repay \$1 million on or before 1 May 2017 and the remaining balance of the loan and interest (\$6.3 million) is due payable on or before 1 May 2018, being a 12 month extension from the previous repayment date of May 2017 for only \$100,000 in interest.
